## Stability of utility-maximization

The effectiveness of utility-maximization techniques for portfolio management relies on our ability to estimate correctly the parameters of the dynamics of the underlying financial assets as well as investor's preferences. In the setting of complete or incomplete financial markets, we investigate whether small perturbations of these input parameters lead to only small changes in the agent's optimal behavior derived from the solution of the related utility-maximization problems.
